## 3. DISCUSSION ITEMS

### 3.1. Discussion of Homeless Emergency Shelter Village

Doug Schulze, City Manager, provided the staff report. Boomer Shannon of Riverside County introduced Greg Rodriguez of the Riverside County "Continuum of Care" Program and Karen Roper, Homeless Solutions Manager from the City of Corona. They both spoke on the topic of homeless shelters in Riverside County and what other cities and communities are doing to address these issues.

#### PUBLIC COMMENTS

**Jamie Hendon** asked about the budget for a shelter in the City and what the plan was in 5 years, 10 years, and so on. He said the Council serves at the citizens' request, and they're spending tax dollars on things the citizens don't want. He asked whose idea it was and said he was ashamed of the Council.

**Yvette Flanagan** asked the Council to have more dialogue with the community. She said the City did not have revenue for homeless services until growth occurs.

**Sue Palmer** spoke on behalf of others in opposition to a homeless shelter in Banning. She said she had spoken to someone who led a homeless shelter who told her they don't turn people around.

**Jeanette Marlar** presented a petition to Council from citizens requesting they not provide a homeless shelter in Banning. She asked the Council to continue this matter until the citizens get a chance to express their thoughts.

**Bill Hobbs** said he felt Beaumont should have to contribute to solving this mutual problem. He said it's a lot of work, but that the City should work together with the citizens to approach this issue.

**Paul Perkins** suggested a citizen's commission be convened on the topic and asked the City and citizens to go into the project with their eyes open.

**Susan Savolainen** spoke about her faith and the teachings of Jesus, as well as her fears the City was enabling the homeless.

**"Team Mom" from Unity Ride for the Homeless** shared her journey as a homeless person traveling the country helping other people in times of need.

**John Hagen** said the City did not need to house the homeless when they may go to a county shelter. He said that 9 out of 10 homeless don't want help, and those who do want help can get it. He said staff were trying to sneak a shelter into the City.

**Bruce Patrick** said that Banning has no extra money, and he suggested the City start paying local faith organizations to help the homeless. He said for the City to take this on is foolhardy and the community will not support it.

**Paul Burkhart** asked about the environmental impact of a homeless shelter. He expressed concern regarding the rumored sites to be under consideration. He asked Council to consider the environmental impact and conduct the appropriate studies.

**Carol Allbaugh** of Faith in Action of the San Geronio Pass said homelessness is everyone's issue and not one organization's responsibility. She was in favor of a community advisory committee and starting small, with a navigation center, for example.

**Tania Hershey** said that the homeless individuals are not temporarily homeless but choose to live that way, dumping trash and doing drugs.

**Shannon Michael** said she was disappointed that the City can't put the homeless on a bus out of the City when the people choose not to get better. She asked why the City would provide a nice place to live and asked if tents and cots were an option.

Assistant City Attorney Serita Young confirmed that a tent would not qualify as providing shelter under the Supreme Court precedent in *Martin v. Boise*.

**Diego Rose** told Council to listen and overcome their cognitive dissonance. He agreed homelessness would be increasing and that most communities are facing this issue. He said the City and County were trying to put a regional homeless shelter in the City of Banning.

**Nancy Guthrie** read a statement on behalf of others, stating that a homeless shelter would benefit all Banning residents. She asked the Council to reach out to nearby cities in Riverside and San Bernardino counties for information on their experiences with establishing transitional shelters for homeless.

**Vickie Sellers** asked several questions about the budget for the project. She asked the City Manager to reach out to the City of Beaumont about partnering on the homeless shelter.

**James Miskofski** shared his experiences with homeless individuals in Ontario. He said the City did not need this shelter and it wasn't right. He suggested taking the homeless individuals out to the Salton Sea.

**Juanita Diaz** asked why no representatives from the Riverside County Sheriff's Office were in attendance when they release people from the jail into the community. She said she wasn't sure who was in charge, and this is done behind citizens' backs. She complained about a local non-profit using storage space at the City-owned armory.

Mayor Wallace read a question she had received via text that asked if the City would work with CalTrans or the railroad to help address the right-of-way areas next to the freeway.

Mayor Wallace announced a recess at 7:21 p.m. The special meeting reconvened at 7:34 p.m.

Mayor Wallace said she wanted to restart the Community Advisory Committee with only six members, including four community members.

City Manager Schulze addressed several of the comments and questions from the public:

- The motion of the City Council was to conduct a Special City Council Meeting, not a community forum. Staff are following Council direction.
- A citizen suggested this item was "popped" on the Council and public, but from 2018 the City Council's direction was to act on the homeless problem in Banning. There was a Homeless Summit in 2019 with approximately 250 attendees and since then there has been countless complaints from business owners, homeowners, renters raised to the City and City Council.
- City Council is listening to residents, but all 30,000 residents don't attend the meetings. Most comments and complaints are received outside of City Council meetings and the Council listens every single day.
- In March 2020, Council directed staff to find shelter for 40 homeless individuals sleeping in the empty lot adjacent to the County courthouse.
- The City has \$180,000 in insurance funds and \$650,000 in grant funds that could be used for the project but expires in March 2022.
- The 22<sup>nd</sup> Street site is off the table, per Council's direction, and there is not a good alternate site in the City. He explained many of the undeveloped properties and so don't have addresses available to provide to the public as was requested by one commenter.
- Many of the people housed at Ramsey Street Village were lifelong residents and did not want to leave the City but couldn't find a way to support themselves in Banning.
- Many homeless individuals will refuse help, but to address the impacts of the homeless who don't want help, the City needs to offer shelter beds.
- The County has not approached the City with plans for a regional homeless shelter. The idea was shared with Mayor Wallace, who was clear about her strong opposition to the concept. No conversations are happening with the County regarding a regional shelter.



- Residents and others have been dumping trash at the homeless encampments. It's not just trash from the homeless contributing to that debris, particularly next to the Williams Street encampment.
- The California legislature added an article exempting all affordable housing and emergency shelter projects from CEQA requirements, so most sites within the City would be exempt from environmental review.
- Staff are aware of jail releases into the community. The Sheriff suggested there were releases into Banning, but that the policy is being corrected.
- CalTrans and the railroad do help the City clean-up the right-of-way areas but it's a slow process to get them out there.

**Gary Hironimus** said that the 22<sup>nd</sup> Street site was never zoned for a shelter and should not have been considered. He said the City was doing an "end run" on the zoning laws and it disgusts him.

**Barbara Djordjevic** of Faith in Action said the City needs to get community buy-in immediately. She said the problem is that residents don't feel safe around the homeless. She acknowledged that finding a site would be a challenge.

Council Member Hamlin asked the community to listen to the experts they bring in and do their research. She said most of the problems cited would be solved by the establishment of a shelter for homeless services. Hamlin supported the idea of restarting the Community Action Committee and suggested they start with a navigation center. She offered to join the City Manager in asking Beaumont to partner on this issue.

City Manager Schulze said that based on the City's current zoning, emergency shelters are only allowed in two zones—high-density residential and mobile home parks. He said the emergency shelter crisis declaration was made to allow Ramsey Street Village to be developed outside those two zones.

**Jeremy Levezu** said he had been talking to Boomer Shannon outside and he learned that the grant money is only to rebuild existing structures in the City.

City Manager Schulze clarified that the County is not administering the grant funds in question.

**Jeremy Levezu** asked staff about how the shelter would operate and the jail release policy. He also asked clarifying questions about how to ask homeless individuals to leave the City.

City Manager Schulze clarified that if the City had shelter beds, they could ask individuals to move along.

**Shannon Michael** asked to know when the community forum would be held.

Staff explained that they could not provide a date before looking at the calendar and considering other upcoming city meetings and events.

### **3. ADJOURNMENT**

Mayor Wallace adjourned the special meeting at 8:15 p.m.

In God's name, what the hell are you guys thinking? When did the citizens of Banning say we want homeless, when did we say, stop the enforcement of current city codes?? When did we stop Code Enforcement?? When did the citizens say build a homeless shelter?

I've lived in Banning for more than 60 years, I've owned a business on the eastside for more than 30 years. When was the last time you asked us, property owners and residences? Up until now, the street improvements for Robertson Gravel, when was the last improvements you have done on the east side. I can tell you; it was a 13-year-old Eagle scout who planted 20 trees on the east entrance to Banning 20 years ago, and the city was to and promised to water them but again, failed the eastside. You want Banning to grow, so do we, so now show us, we are tired of the BS talk.

What is the first thing, impression you see coming into Banning from the East, a trashed homeless area. Homeless walking the streets, trash everywhere. Ask us who own there and attempted and attempting to survive on city promises. Eastside is the lowest income area in Banning, and you want to make it a dumping ground for homeless that only you and the city manager wants?

My business, now vacant, was broken into 10 times in a 4-week period, by homeless, yes, homeless. I'm less than a block away from the previous shelter. Trash daily, clothes, food trash, homeless shelter stuff, blankets, tarps cardboard, human waste. Security bars ripped from the building, security cameras damaged and removed, windows broken, doors kicked in, the list goes on, thousands of dollars in damages, and you are ok with that, and yes, it was the homeless. I was never so glad to see the homeless shelters burn down, my issues stopped, I've made repairs, people are starting to show interest in the property. Now you want to bring them back???

Homeless need adult supervision, which the city has not provided, they need treatment, the city and county has not provided. They do not need housing; everyone has a place to sleep and not one is sleeping on the public bus benches. They need treatment and services. Almost none of these are Banning residences, they are not our problem, and we should not make it our problem. We are not and do not want to be the dumping ground. It is far cheaper to put them on a bus to their last known address than make it our problem! I'm not heartless, I'm tired of this issue you have created and allowing to happen.

I understand the food kitchens, I've assisted all of them over the years, and none of them were started for homeless, they slowly transitioned to that, I truly understand your point, I understand caring for God's children, food, clothing and whatever, but we all are fueling the problem, we are making Banning a magnet to the homeless, it needs to stop, all of this now, and it needs to stop with this council, no more excuses, no more blaming the past, it is your issue to fix. If you want a homeless shelter, put it next door to your house, put it in the parking lot next to the police department and move their vehicles to the city yard. At least the police department can look out the window and see what's going on as that never happened on East Ramsey. Put it next to Sun Lakes, it will get fixed then! No offense to my friends there, I know you would fix this issue the city has created.

This is it, if this move is approved, every council member, every city official should be looking for a new home, a new job, we, the citizens of Banning are done with stupid decisions, time to fix this. We are not the dumping ground for homeless, nor do we wish it to be.

**To the City Clerk of Banning**

I ask this letter and its attachment be read at the City Council meeting this September 7, 2021. **A Special Call Council meeting of the City of Banning.**

Questions to the City Council and/or City Staff. I ask for answers be given to the Citizen tonight before any votes are taken.

#1 If there were no Grant Money involved, would you be trying to do this Homeless Shelter Project?

#2 Where would you get the funds to do this program without a grant?

#3 Where in the **2021/2022 budget** is this program of the Homeless to be found? Where in the **2020/2021 budget**?

#4 Which **account** will theses expenses show on the budget and line items?

#5 Do you have the **approval** of this project from Ford Motor Corp. per the 1997 agreement for the 22<sup>nd</sup> street (7.78 acres).

#6 When the grant ends, where will the money come from to keep this program going and where will these funds come from at that time? Please explain tonight.

There are many questions yet to be asked and must be answered before into this program. I hope you realize what you are about to do to the 30,000 Citizens of Banning while trying to solve 90 people or less. They have problems and they truly do not want our help. They only want money for their drugs.



**Below** you will find an **estimate of the cost to the citizens of Banning** that has already occurred. **What more do you think the citizens of Banning should do?** How can you justify and ask even more from the citizens of Banning? **Please tell us tonight.**

### **Loss of dollars to the City's Citizens of Banning**

**In this loss**, you must remember that is a loss to the **School District, Hospital District, Library District, San Gorgonio Pass Water District and the FC-FLD CNTL Stormwater/Cleanwater District.**

These are on your Property Slip that is issued by Riverside Count Annual **Secured Property Tax Bill.**

#1 649 West Lincoln Street at the time removes from Tax Roll value of **\$9,000,000**. Had it not been damaged by the Homeless the Tax Value to the Citizens and its Tax Districts would have been well over **\$26,000,000. Annually.**

#2 The cost to the Tax payers by way of Fire Dept. estimated **\$500,000**. to fight the **fires** 8 to 10 different times at 649 W Lincoln street. This cost could be higher.

**#3** The Fire Damage of the motel on West Ramsey street was estimated to be some where about **\$500,000. Loss to the City.**

**#4** Loss of property tax again to the Citizens and all of the Districts plus the loss of the motel tax of 12% (\$7500. Annually or more). One does not really know the true loss at the time!

**#5** The building on West Livingston street with the cost of putting out the fire and the amount that was again removed from the Property tax is well over **\$75,000.**

**#6** The Building at San Gorgonio and Lincoln street on the north west corner has a loss of Property Tax and the cost of the Fire Department in the millions of dollars. Was the cause by the homeless? I don't know. You tell us.

**#7** At 300 West Lincoln (my Property) \$3850. To replace all of the front windows, as well as my home 2021 W. Wilson Street with a damage estimate of \$1000.

**#8** The total cost of the Homeless Shelter burning down on East Ramsey Street has not been disclosed to the citizens that I am aware of.

**#9** What has the cost to the Banning Police Department been also? I am sure over a **\$1,000,000.** Maybe even more. You the Council should ask that staff gives you a true dollar report and where the money came from and is going.

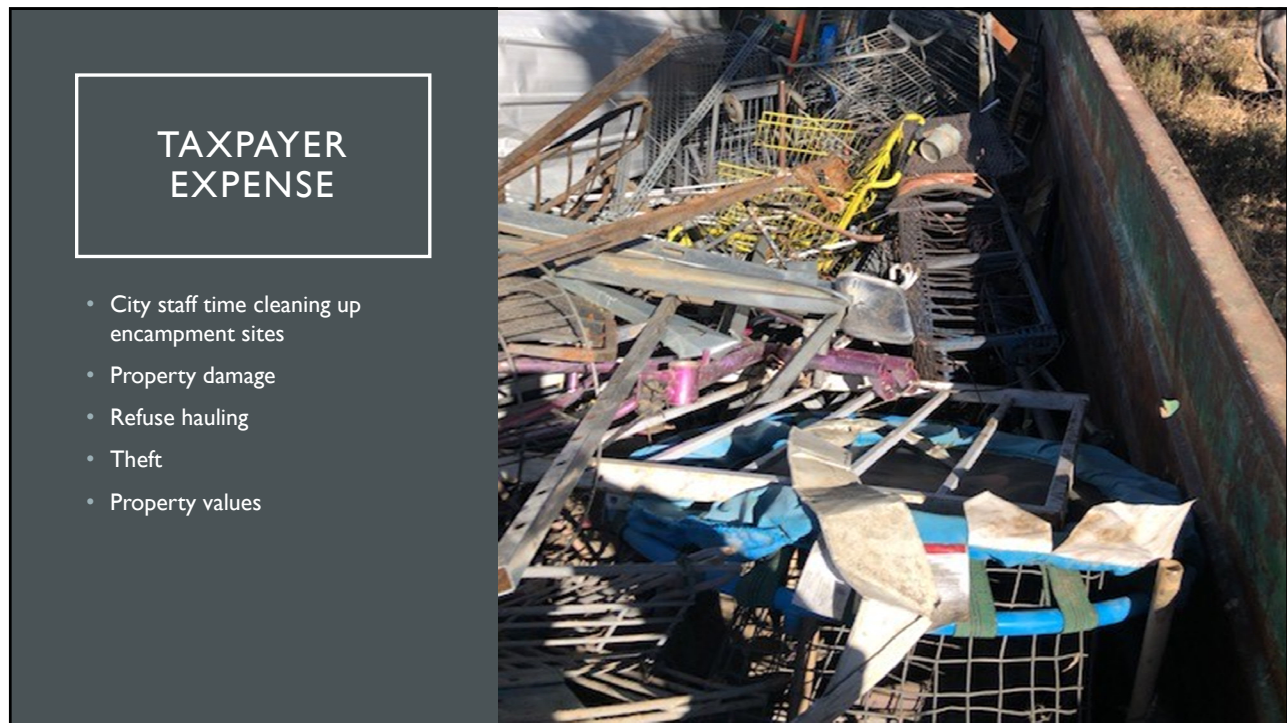

- COVID-19 Pandemic Emergency Action
- Goal to get 40 homeless individuals into shelters and out of an abandoned building
- Minimal planning – just shelter
- Many lessons learned
  - Must have 24/7 staff or security
  - Must have a program
  - Drug testing, random and regular unit searches
  - Maximum stay of 60 – 90 days

### FAILURE?

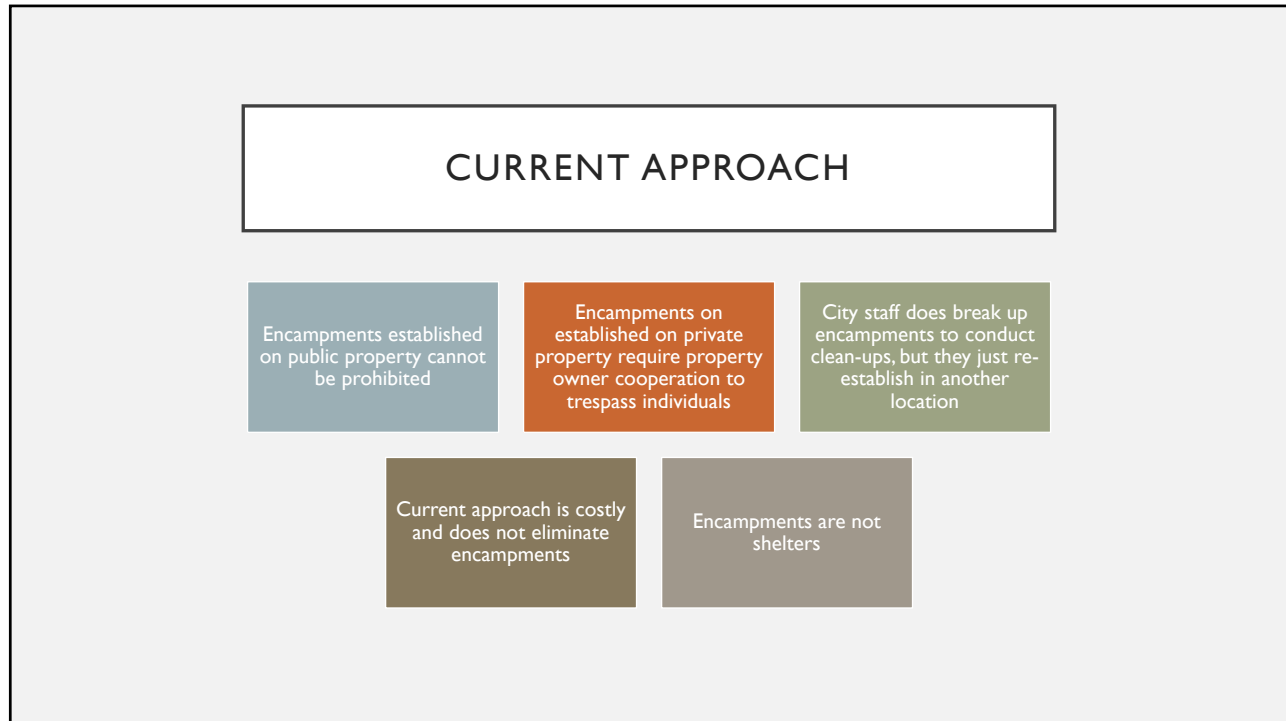
- 9 months of shelter for 40 homeless individuals
- Crime did not increase
- Several individuals placed in permanent housing
- County & City representatives visited Banning to see Ramsey Street Village and learn from us
- Other Counties & Cities have replicated Ramsey St Village.



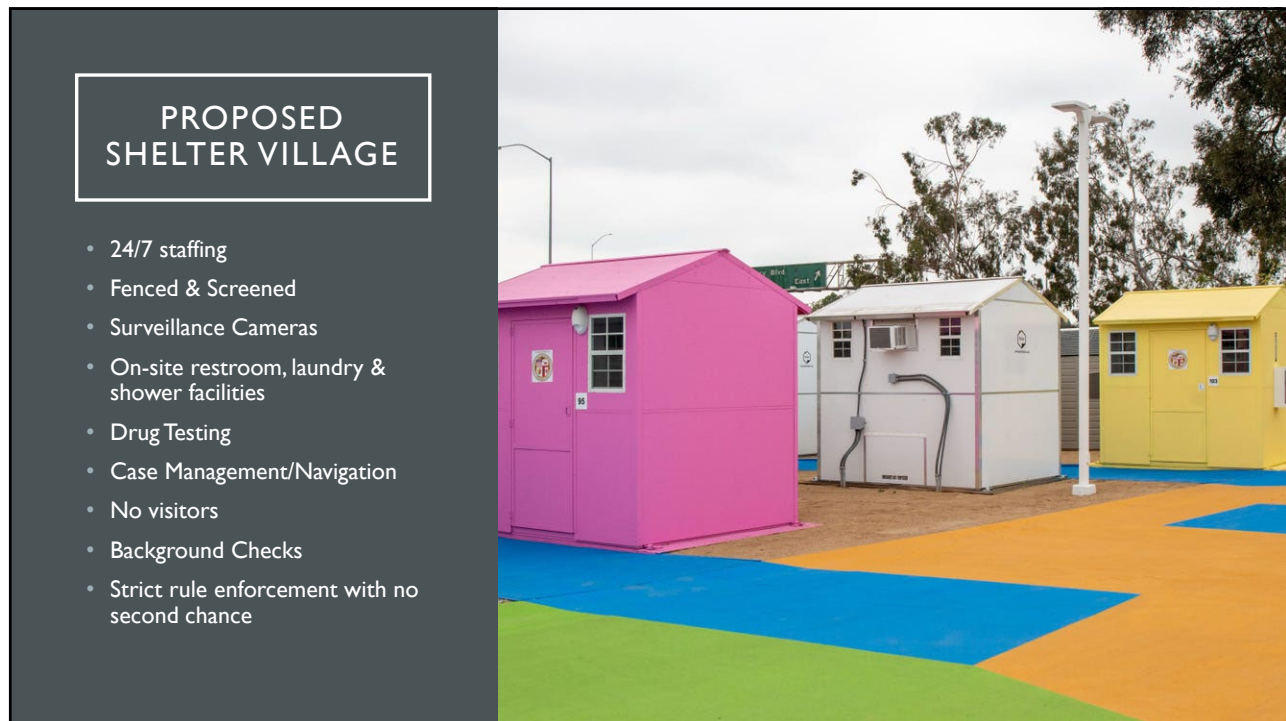

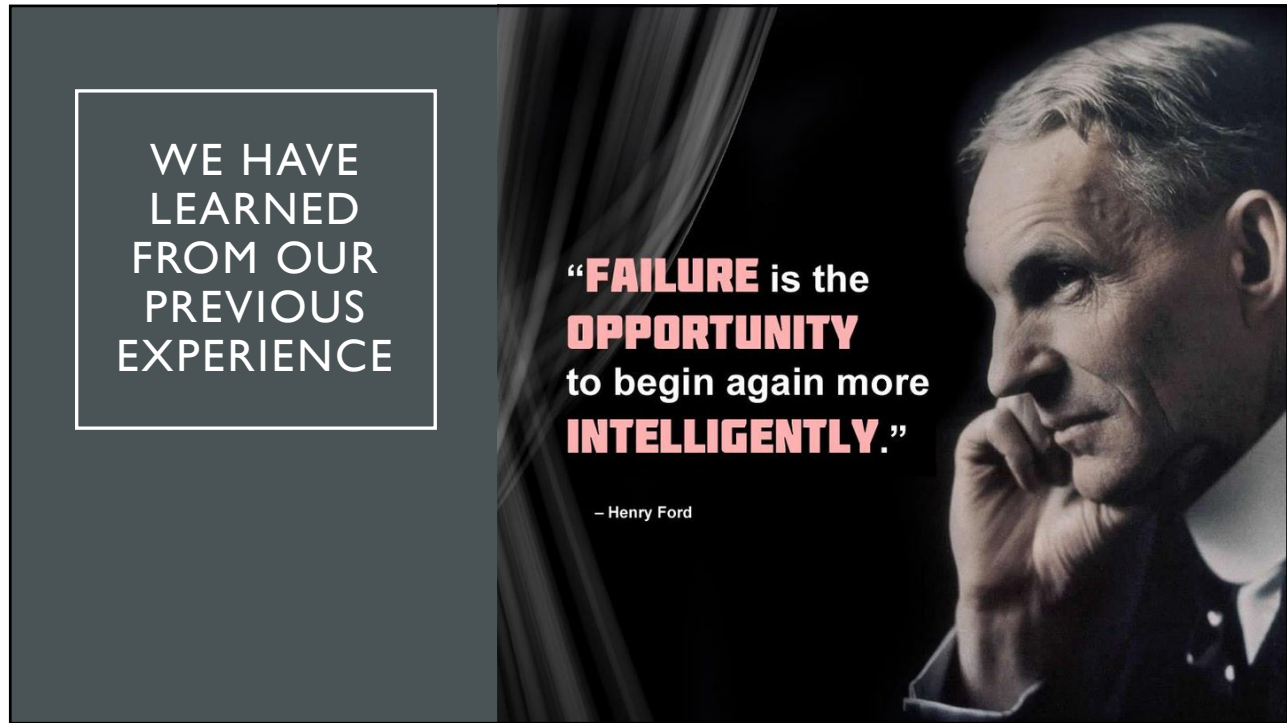
### WHAT IF WE DO NOTHING?

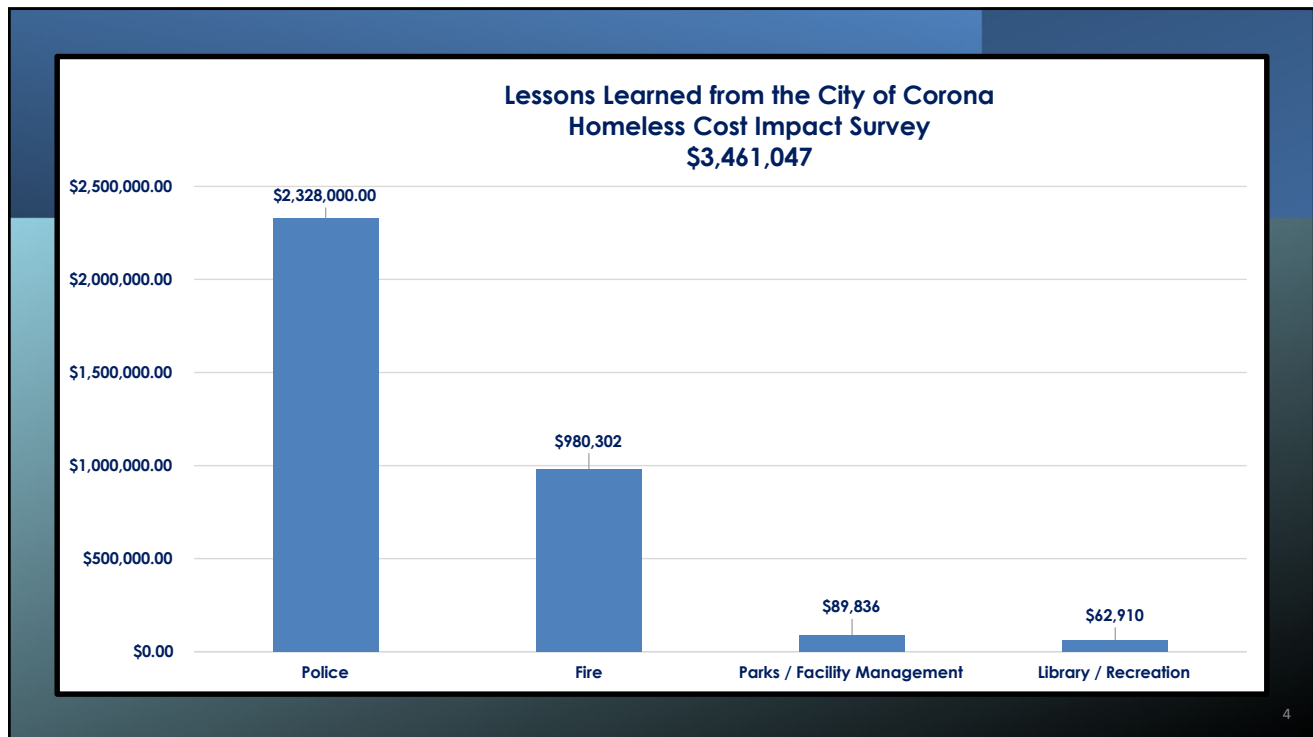

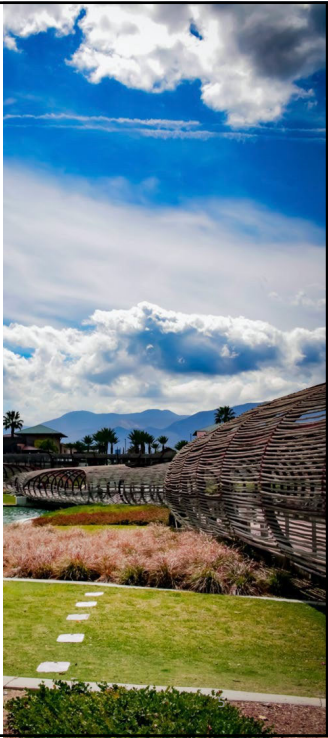
