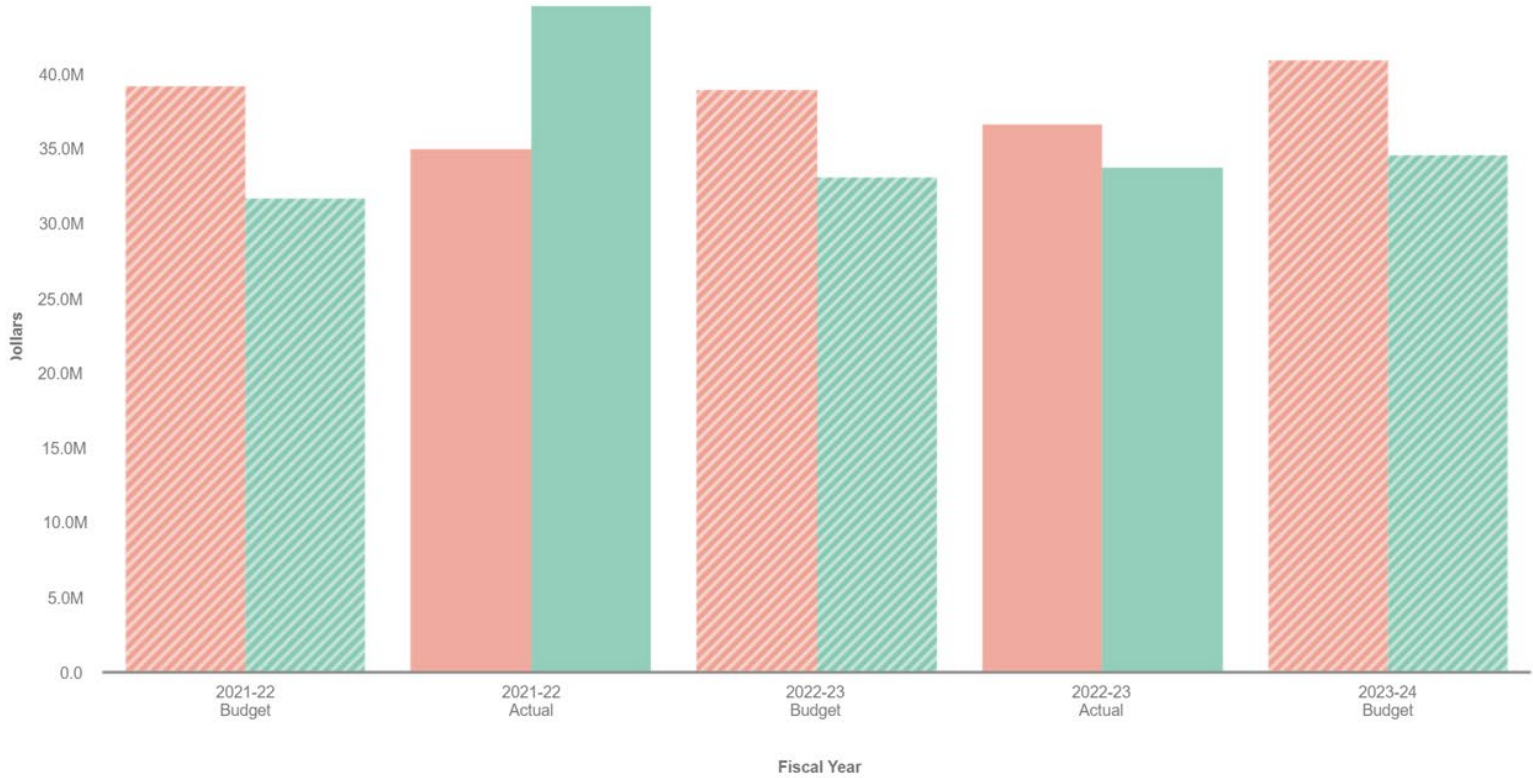

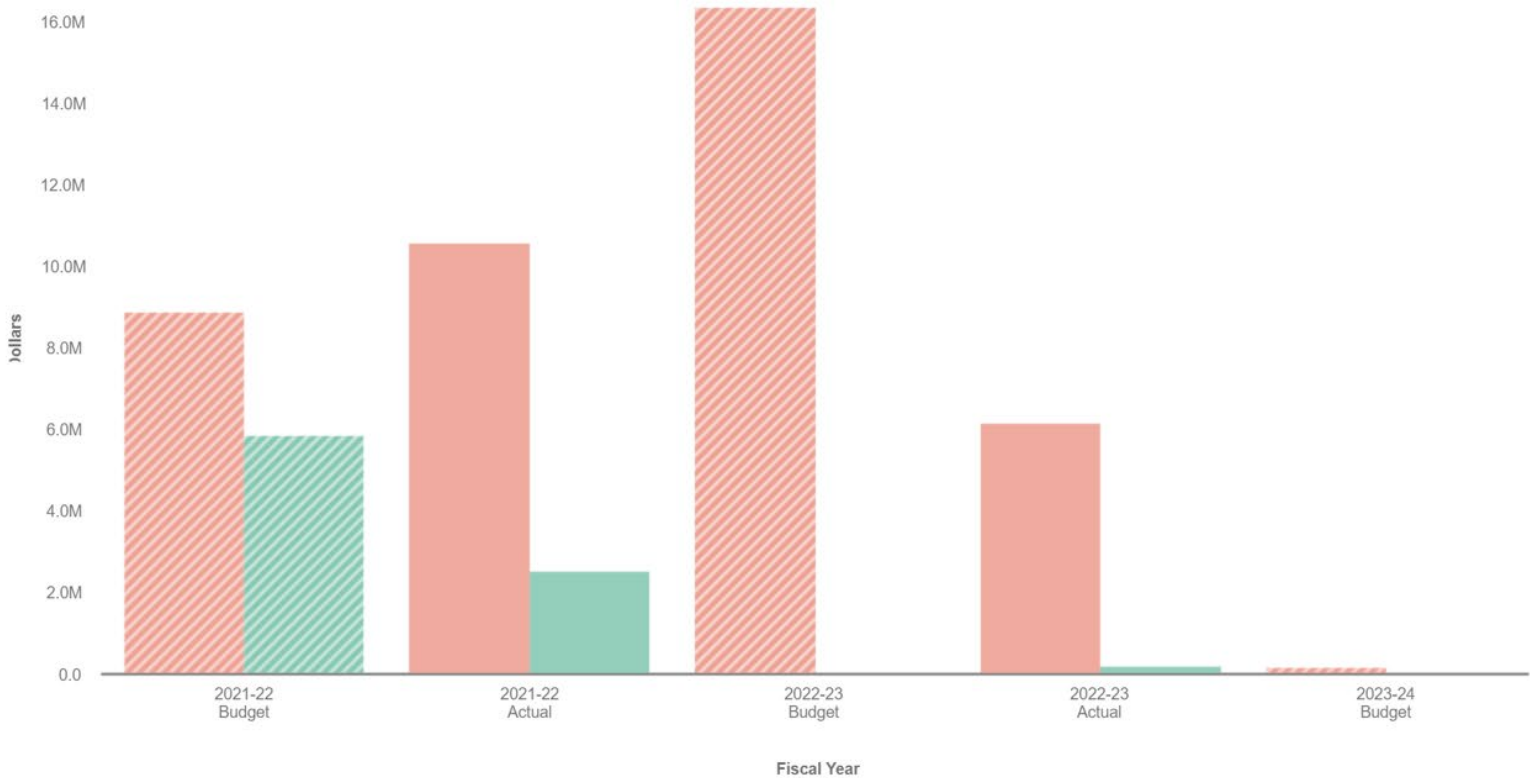


Electric Enterprise Preliminary Results of Operations

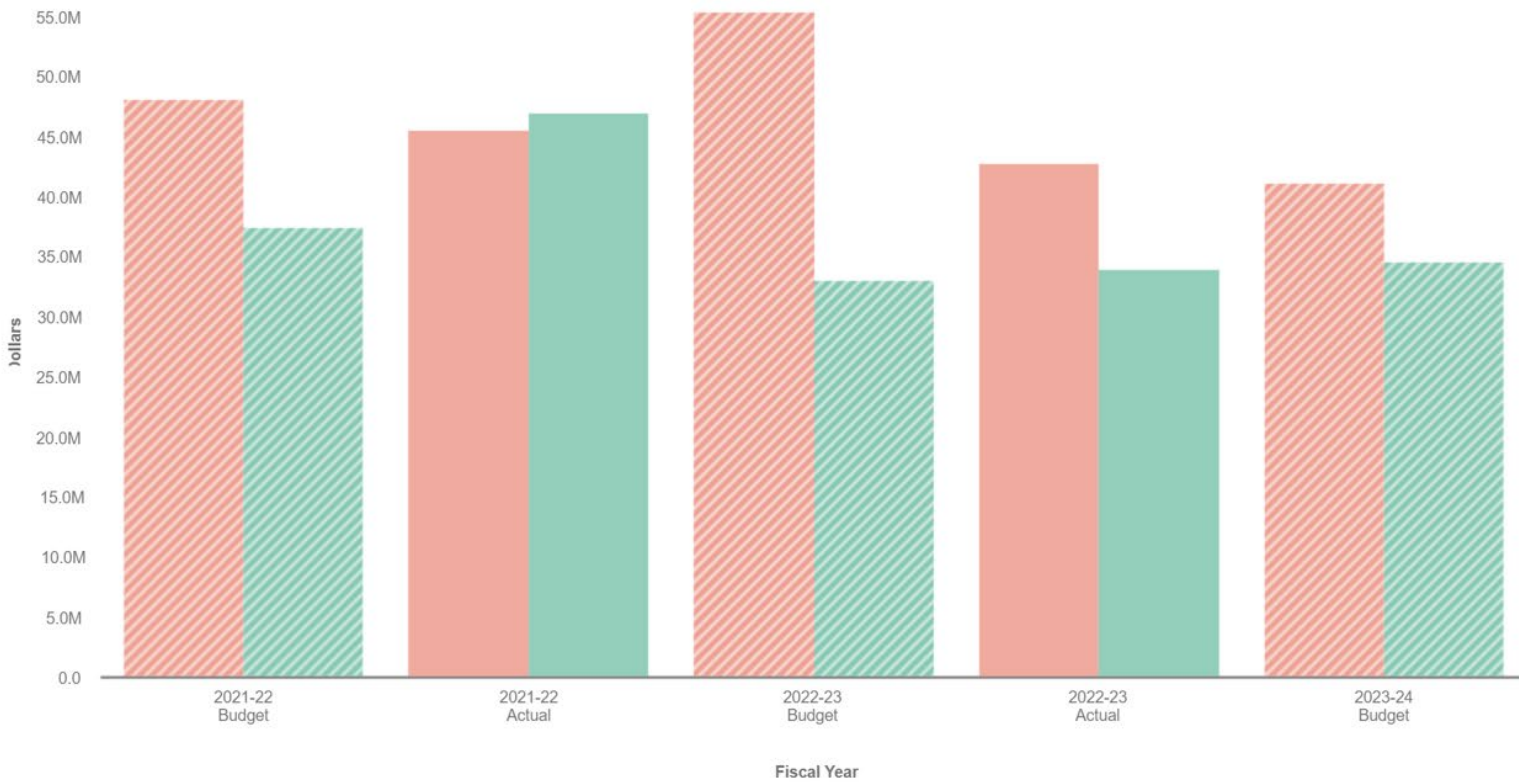
