I want to point out First of all that the Auto Group Contracts had nothing to do with this present City Council of Banning, City Deputy Clerk, City Attorney, City Manager, Purchasing Office and or the Administrative Services Director of Finances Dept.

But I also want to point out that each of the above as of their Dates of Hiring and or their Dates Elected became Responsible Party to carries out the agreement and Resolutions in behalf of the Citizens of the City of Banning. It is your duty and Responsible.

Therefore you shall review each and all of the Auto Groups agreements responsibility in behalf of the Citizens of Banning, While it will be stated that the 2005 Contract is no longer the Contract. 2005 Contract did not have a Resolution in it. Please explain why there should be Resolution in the first place.

Onlythe 14 pages Plus Exhibit (A-B-C). While the Amended and Restated Agreement of 2012 is the next one. It has 24

pages of an Agreement as well a Resolution 2012-59 of 5 pages. Keeping in mind that there is a third agreement, one of which is dated 2016. The 2016 agreement is a amendment to the 2012 agreement. And one must question the right date to use on this one. Will try to explain later down the road.

While the 2005 Agreement has come and gone by all Purposes, I still want to point out the Defaults of each Section of the contracts has not been carried out and enforce by the then City Council and or the City Attorney or City Mangers. These next few pages will be on the 2012 Amended and Restated that was pass. The dates are all over the place as you will see if you read the Agreement and Also the Resolution.

Again, this part of the Auto Groups was not done by the present City Council or any member of the present Staff. However the Present Council and Staff members of the City of Banning shall see that it is carries out in the interest of the City of Banning Citizens and that the agreement be carried out per the written **Resolution 2012-59 and Agreement sign 11/13/2012 must be Honor by both parts of the Contract.**

The Commencement Date was to have been January 1, 2012, agreement. But was not sign until 11/13/2012.

Per Item 1. THE EFFECTIVE DATE: AND IT READS

This Agreement will not become effective until it (i) has been duly executed by the authorized officers of the Dealership and delivered to Banning and (ii) has been duly approved by the City Council of the City of Banning. (the "EFFECTIVE DATE "Per the Mayor, City Clerk and City Attorney as well are the Signatures and dates OF 11/13/2012.

You will note that the Resolution 2012-59 was pass July 24, 2012. Signatures by the same, Mayor, City Clerk and City Attorney. 4 MONTH EARLYER.

You will also note that they talk of a June 12, 2012, in the Resolution about an Ordinance adding Chapter 3.28 to the Banning Code, Again, if you will check out Chapter 3.28, has nothing to do with anything to this agreement. **The Title of Chapter 3.28 is Insurance Fund. Check it out.**

What is wrong in this part of the agreement the City Paid the Auto Group 4qtr of 2011 and 1,2,3,4 qtrs of 2012. \$44,266.00. **A Violation** of the Agreement and Resolution.

(Notice I am talking about differ Recital)

2.3 of this agreement (2012) went away when they form this new agreement of **Amended/ Restated agreement.**

2.4 2.5 2.6 **(The talk of the Recession effected everyone not just the Auto Groups those days).**

2.7 Explain, what the 2005 Original Agreement has to do with this now 2012 agreement. In parts of this agreement, you will see where Auto Group (iv) & (v) was to make various upgrade and improvements to their Existing property's. (NO Permits was every pull for any improvements until 2019) First Permits on Record with City is 2019 Permits **#18-00000156**. The Deanships has been in its location since sometime around 1965.

2.8 No verification of the total Employee as ever been made. Verification would by way of the number of W-2 or 1099 form issued for 2012-2013-2014-2015 up to the next change that took place in 2016 as well. (Later in this letter)

2.9 Again, **Please review Chapter 3.28** and how it fits into this agreement. It also speaks of amendments outlined in Recital

2.7. This is any agreement to Amended & Restated not an amendment to 2005 agreement.

3. TERMS OF OPERATING COVENANT & SALES TAX SHARING

3.1.1 BASE AMOUNT FOR THE CITY WENT FROM \$200,000.00 DOWN TO \$1,00,000.00 BEFORE SHARING WITH AUTO DEALERSHIPS AND SPLIT WENT 50% TO DEALERSHIP. (2012)

8. RESTRICTIONS OF TRANSFER

8.1 Diamond Hills Auto Group, Inc, November 9, 2015 sold and assigned its interest in the Property to Dalia Auto Group, Inc. with out approve. On August 23, 2016, 10 months later the City was notify of the sale, City is still HONORING and paying the qtr payments, Total \$110,443.00.

A VIOLATION of the Agreement and or Resolution.

August 23, 2016 City Council Meeting Resolution No. 2016-80 Under Consent items 11 page 251 of the agenda, Consideration and Approval of Resolution N0 2016-80 was pull from the agenda for more information. At that time the Resolution 2016-80 read like this, *Consideration and Approval of Resolution 2016-80, Authorizing the Transfer of the Agreement for Diamond Hills Auto Group, Inc. Operating Covenant (Sales Tax Sharing Agreement) to Dalia Auto Group, LLC. You will find that the Transfer of Diamond Hills Auto Group to Dalia Auto Group Was never approved by the Council.

What took place at a later date 12/12/2016 by the City Manager (Rock) and the Deputy City Manager was a Resolution 2016-80 with differ names on it. Reads like this.

A Resolution of the City Council of the City of Banning California, APPROVING THE AGREEMENT FOR SALES TAX SHARING AND OPERATING BETWEEN THE CITY OF BANNING AND DALIA AUTO GROUP, LLC AND KHAN PROPERTIES AND HOLDINGS, LLC, DOING BUSINESS AS DIAMOND HILLS CHEVROLET BUICK GMC PRESENTED OR AMENDED BY CITY COUNCIL FOLLOWING PUBLIC COMMENT.

No one did their homework on this matter. This all took place from August 23, 2016 to January 12, 2017, At a cost of the Citizens of Banning in the amount of \$301,733.00. All because of poor Management and Council decisions of not watching the Store. Please don't let this happen to you folks.

What I see was the illegal Transfer of the DaLIA GROUP, KHAN LLC AND THE MANAGEMENT OF THE CITY, MEANING, THE CITY COUNCIL, THE CITY MANAGER, HIS STAFF, THE CITY ATTORNEYS AND CITY CLERK. While the citizens of BANNING AGAIN IS THE LOSERS.

While I don't agree, you now have A New Agreement. City of Banning, and Dalia Auto Group, LLC AND KHAN PROPERTIES AND HOLDINGS, LLC. COMPANIES, DBA: DIAMOND HILLS CHEVROLET BUICK GMC A LIMITED LIABILITY COMPANY, you will see that

there is no date on the agreement but by the Notary Stamp on JUNE 13 , 2017. BY USING THE SECOUND RESOLUTION 2016-80, WE NOW CAN MOVE ON.

1. EFFECTIVE DATE WHEN it HAS BEEN APPROVED BY THE CITY COUNCIL.
2. 2 , HOW THAT FIGURE IN ON THIS AGREEMENT as NO NEW DEALER FRANCHISES HAS been added.

BASE ON 2.3 IT WENT IN SERVICE AS OF NOV. 9, 2015, with out the City COUNCIL approval. WHICH MEANS THAT NO PAYMENTS Should HAVE BEEN PAID UNTIL JUNE 13, 2017.

But qtr payments were paid in the amount of \$374,828.49 during the time Agreement was not sign by all parts.

There are many Unfulfilled items through this Contract and or Agreement as well as the Resolution 2016-80 .

2. RECITALS AND REPRESENTATIONS

The Effective Date, Illegit Transfer, THE DEALERSHIP HAS CONSIDERED RELOCATION TO NEARBY CITIES, (can't jump up and run to another city without GMC okay and what a cost it

would be. Plus, the lost time waiting to build. City has failed to check on the number of employees by way of W-2 or 1099 TAX REPORT FORM. City has failed to verified the dollars on improvements that has been made.

In reading this, The Resolution 2016-80 (kept in mind that a Transfer between Diamond Hills Auto Group and Dalia Auto Group, LLC never took place). As you read on of which is between City and Dalia Auto Group, LLC and Khan Properties and Holdings, LLC, doing business as Diamond Hills Chevrolet. Buick GMC. (three differ company's).

Words of Whereas comes from Resolutions, Whereas #3 of 11, is of Dalia Group, Khan Properties, and Holdings, LLC.

Whereas # 5 of 11, Dalia purchased Diamond Hills Group located at 4545 W. Ramsey Street and 4661 w. Ramey Street Banning, Ca. Nothing about Khan Properties only Dalia Auto.

Whereas # 9 of 11, City to provide Assistance to Dalia in purchasing additional parcels with freeway **front signage**, renovation and expansion of the dealership. (While purchasing may have been made but no Renovation has taken place. **(This is a Default project.)** Year 2016 to now year 2023. **7 Years** of receiving funds from the Citizen of Banning Total in 7 years is \$1,775,309.26. What did the Citizen of Banning get in return is the question.

This Resolution 2016-80 must be Void and stop the funding of the Dealership which is not keeping with the agreement that they sign June 13, 2017.

The 2016 agreement, total 18 pages Mark as 260-F to 260-Z Sign June 13, 2016. There is so very little difference then the 2012 agreement.

1. **EFFECTIVE DATE, WAS NOT FOLLOW.**
2. **ALRECITS AND REPRESENTATION**
 - 2.2 *Differ numbers, wording as 2005 and again in 2012.*
 - 2.3 It not honest and is very wrong, It states in part that on November 9, 2015 that Dalia Auto Group, LLC and Khan Properties and Holding, LLC. Purchase Diamond Hill Auto Group. Please review the August 23, 2016 City Council Report Meeting Agenda. From City Manager Michael Rock, and Prepared By Ted Shove, Economic Development Manager.
 - 2.4 Again, need to check W-2 and 1099 Form to verify the number of full time Employee's
 - 2.5 Again. The **threat** of moving to another City. First of all once again they would need GMC approve to do so.
 - 2.8 There is no mentioning in either of the two different resolutions 2016-80 of any amount up to **\$3,200,000.00 That would be paid to the Dealerships.**

3. TERMS OF SALE TAX SHARING

(B) Effective Date *You will find once again payments were made before approved. June 13, 2017 when all parts had sign.*

(C) "MAXIMUM PAYMENT" *Dealership shall not be entitled to payments from, City beyond the fifteen (15) year term, or in excess of the Maximum Payment consistent with this agreement

(J) "Dealership Improvements" under (III) adding a new freeway frontage sign to the newly acquired property adjacent to the facility and identified by Assessor Parcel Number 537-100-027=7,537-100-028-8 = 537-100-020-9 (Nothing has been done) A Violation.

This is just a few of the **Violations** in this agreement and as well in the Resolution 2016-80. It is your duty to go over the Agreements and Resolutions 2016-80. To see that the Citizens are Protected. From the beginning of 2005 to the present 2023 this has not been right. All of these agreements and Resolutions have been in favor of the Auto Groups.
